Article 1: Evaluation criteria

1.1. Regular evaluation criteria:

- Fully meet the specific requirements of lecturers;
- Ability to summary of learned knowledge;
- Ability to withdraw research;
- Reflect self-learning knowledge.

1.2. Mid-term evaluation criteria:

- Know the basic knowledge of the component subject, relevant concepts and laws learned by the time of evaluation;
- Understand the knowledge of the component subject learned to the time of evaluation;
- It is feasible to use, using learned knowledge at the time of assessment, to solve simple legal situations;
- Ability to analyze acquired knowledge up to the time of assessment.

1.3. Final exam evaluation criteria:

- Know basic knowledge of the subject, concepts and provisions of relevant laws;
- Understand the knowledge of the subject;
- Ability to use knowledge to solve simple legal situations;
- Ability to analyze acquired knowledge;
- Ability to synthesize knowledge not only within the scope of the subject but also related knowledge, formulating systematic legal thinking;
- Ability to detect, forecast and evaluate emerging legal issues, capable of providing legal solutions that have practical values.

Article 2: Grading scale of final exam

The mark for the final exam of each component subject are scored on a scale from 0 to 10, odd to 0.5 according to learner competencies, specifically as following:
