3.2. Training sequences:

- **a.** Opening: The first week of the first school year
- **b.** Organizing learning and course assessments: Semesters 1, 2, 3 (From the 1st month of the first school year to the end of the 3rd month of the 2nd school year);
- **c.** Organizing the evaluation of the outline, approving the thesis topic: At the end of the 3rd semester (the third month of the second school year);
- **d.** Making a decision to recognize the thesis topic, appoint an instructor: At the beginning of the 4th semester (From the 3rd to the 5th month of the 2nd school year);
- **e.** Students write thesis: Semester 4 (From the 4th to the 6th month of the 2nd academic year);
- **f.** Students report the progress of their thesis to the Departments: At the end of semester 4 (the 6th month of the 2nd school year);
- **g.** Students submit their thesis and relevant documents in the 1st batch: 8th month of the 2nd school year;
- **h.** Make a dossier to request the establishment of a thesis grading committee: 8th month of the 2nd school year;
- i. Organize the thesis defense in the 1st batch: The 9th month of the 2nd school year;
- **j.** Prepare a dossier of request for recognition of the degree and grant of the 1st batch of diplomas for eligible students: 10th month of the 2nd school year.

3.3. Notes:

- The organization of learning and assessment of the courses is carried out from the 1st to the 3rd semester of the program.
- The implementation of the student's thesis and the organization of the thesis defense takes place in the 4th semester of the program.

- The official duration of the master's program is 2 years, students can extend the duration and thesis defense but must not exceed 4 years.

IV. SUMMARY OF MODULES

1. SOL6001. LEGAL RESEARCH METHODOLOGY

This course aims to provide graduate students with fundamentals of legal research methodology and equip students with theoretical knowledge about different research methods and how to select and combine scientific research methods to achieve the goal of legal research most effectively. The course also helps students practice essential skills of scientific research, how to conduct a research project, and effectively use research methods in other fields of legal science.

2. CIL6040. REAL RIGHTS

This course aims to provide students with knowledge of concepts, classifications, legal effectiveness, bases for establishment and termination of different real rights, as well as methods for protecting real rights in case of infringement.

3. CIL6041. LAW ON EXTRA-PATRIMONIAL RIGHTS (PERSONAL RIGHTS)

This course aims at providing graduate students with modern, in-depth, up-to-date knowledge of law on personal rights and the skills to apply such knowledge to assess Vietnamese law, to find gaps and propose solutions to improve Vietnamese law on personal rights.

4. CIL6042. COMPARATIVE CONTRACT LAW

This course aims at providing graduate students with modern, in-depth, up-to-date knowledge of comparative contract law in civil law system and common law system, development trends of contemporary contract law, basic content of international conventions or model laws such as the Principles of International Commercial Contracts; thereby helping students in comparing, contrasting and evaluating characteristics of

contract law models in the world with Vietnamese contract law, analyzing the relevance and compatibility between Vietnamese contract law and the development trends of contemporary contract law in order to propose solutions to improve Vietnamese contract law.

5. CIL6043. LAW OF INDUSTRIAL PROPERTY RIGHTS AND PLANTS VARIETY RIGHTS

This course aims at providing graduate students with in-depth knowledge of law on industrial property rights and plants variety rights and the skills to apply such knowledge to solve practical problems, to assess Vietnam's current law on industrial property rights and plants variety rights protection, to find gaps and propose solutions to improve the efficiency of industrial property rights and plants variety rights enforcement.

6. CIL6044. EVIDENCE AND PROOF IN CIVIL PROCEDURE

This course aims at providing graduate students with modern, in-depth knowledge of evidence and proof in civil procedure and the skills to apply such knowledge to solve legal problems in practice, to assess Vietnamese civil procedure law of evidence and proof, to find gaps and propose solutions to improve Vietnamese civil procedure law in this area.

7. CIL6045. GENERAL THEORY ON THE LAW OF OBLIGATIONS

The course provides students with a system of in-depth knowledge related to the general theory of the Law of Obligations such as concepts, classifications, legal features, basement for termination of obligations.

8. CIL6046. THEORY OF CIVIL LAW SOURCES

The course "Theory of civil law sources" aims to provide students with a deeper understanding of different civil law sources, their characteristics, nature, classification, role, and application, enable students to apply such knowledge to solve problems related to civil law issues, mainly theoretical and practical issues focused on legal acts; legal documents; customs; the analogy of law; basic principles; case law; justice

9. CIL.6047. LAW OF COPYRIGHT

This course aims at providing graduate students with in-depth knowledge of law on copyright and the skills to apply such knowledge to solve practical problems concerning copyright law, to assess Vietnam's current copyright law, to find gaps and propose solutions to improve the efficiency and effectiveness of copyright enforcement in Vietnam.

10. CIL6048. LAW OF NON-CONTRACTUAL DAMAGES LIABILITY (TORT LAW)

The course aims to provide students with an in-depth knowledge of the general theory of the law of non-contractual damages liability (Tort Law) such as structure, function, legal characteristics, subject, and basic principles, and enable students to apply theory and law on compensation for non-contractual damages liability to solve practical problems.

11. CIL6049. MATRIMONIAL PROPERTY REGIME

The course "Matrimonial property regime" aims at providing graduate students with indepth knowledge of matrimonial property regime and the skills to apply such knowledge to solve the practical disputes in Vietnam, to find out gaps and propose solutions to improve Vietnamese matrimonial property regime law.

12. CIL6050. LAW OF CIVIL JUDGMENT ENFORCEMENT

This course aims at providing graduate students with modern, in-depth knowledge of law on civil judgment enforcement and the skills to apply such knowledge to solve legal problems in practice, to assess Vietnamese law of civil judgment enforcement, to find gaps and propose solutions to improve Vietnamese law of civil judgment.

13. CIL6051. DIVORCE AND ITS LEGAL CONSEQUENCES

The course "Divorce and its legal consequences" aims at providing graduate students with in-depth knowledge of divorce and the skills to apply such knowledge in order to solve the practical disputes in Vietnam, to find out gaps and propose solutions to improve Vietnamese law on divorce and its legal consequences.

14. CIL6052. APPLICATION OF THE CIVIL CODE TO BUSINESS, COMMERCIAL AND LABOR DISPUTE RESOLUTION

The course aims to help learners understand the application of the Civil Code appropriately and enhance their problem-solving skills to resolve business, commercial, and labor disputes. The course clarifies the relationship between the Civil Code and other sources of commercial and labor law. It builds skills related to case analysis, normative analysis, and problem-solving if there are no specific regulations on business, commercial, and labor relations.

15. CIL6053. INHERITANCE LAW

The course provides students with in-depth knowledge of inheritance law from a theoretical perspective to current Vietnamese law. Specifically, the course provides the following knowledge: Some basic concepts and legal issues in the general part such as the leaver, heir, inheritance, inheritance management, the statute of limitations for initiating an inheritance lawsuit; Legal issues of wills and wills validity; Inheritance issues according to the law such as inheritance and inheritance.

16. CIL6054. LEGAL PERSONS

The module equips learners with information and knowledge about the theory of legal persons, the classification of legal persons, and the organization and operation of legal persons and aims to build skills in settling disputes relating to legal persons. The module also provides in-depth knowledge of legal rules for each specific type of legal person.

17. CIL6055. INTERLECTUAL PROPERTY DISPUTE RESOLUTION

This course aims at providing graduate students with in-depth knowledge of intellectual property (IP) dispute resolution and the skills to apply such knowledge to solve IP disputes in practice, to assess Vietnam's current situation of IP dispute resolution, to find gaps and propose solutions to improve the efficiency and effectiveness of IP dispute resolution in Vietnam

18. CIL6056. THE LAW OF AGENCY

The course provides students with in-depth knowledge of representative law from a theoretical perspective, current Vietnamese law, to comparative law. Specifically, the module offers the following expertise: Concept, function, structure of representation; Some of the legal issues related to the agent are not authorized representation and agent abuse of authority.

19. CIL6057. LAW OF TRANSPORTATION CONTRACTS

The course equips learners systematically and intensively with knowledge and skills related to the law of transportation contracts, specifically contracts for transport of passengers, contracts for the transport of property with either shipping fees or free shipping and either standard shipping or irregular shipping by different means of transportation.

20. CIL6058. LAW OF LEASING

This course aims at providing graduate students with modern, in-depth knowledge of comparative civil procedure law and the skills to apply such knowledge to assess Vietnamese civil procedure law, to find gaps and propose solutions to improve Vietnamese civil procedure law in line with global trends.

21. CIL.6059. LAW ON ASSOCIATION CONTRACTS

This course aims at providing graduate students with modern, in-depth knowledge of law on association contracts and the skills to apply such knowledge to assess Vietnamese law, to find gaps and propose solutions to improve Vietnamese law on association contracts.

22. CIL6060. COMPARATIVE CIVIL PROCEDURE

This course aims at providing graduate students with modern, in-depth knowledge of comparative civil procedure law and the skills to apply such knowledge to assess Vietnamese civil procedure law, to find gaps and propose solutions to improve Vietnamese civil procedure law in line with global trends.

23. CIL6061. COMPARATIVE MARRIAGE AND FAMILY LAW

The course "Comparative Marriage and Family Law" aims at providing graduate students with modern, in-depth knowledge of comparative marriage and family law and the skills to apply such knowledge to assess Vietnamese marriage and family law, to find gaps and propose solutions to improve Vietnamese marriage and family law in line with global trends.

24. CIL6062. LAW ON COLLECTIVE CONTRACT

This course aims at providing graduate students with modern, in-depth knowledge of law on collective contracts and the skills to apply such knowledge to assess Vietnamese law, to find gaps and propose solutions to improve Vietnamese law on collective contracts.

25. CIL6063. ADVANCED ROMAN LAW

This course aims at providing graduate students with modern, in-depth up-to-date knowledge of Roman private law and to compare with and to find gaps and propose solutions to improve Vietnamese civil law.

6.2. Assessment of the learning results

Students' learning results are assessed after each semester according to the following criteria:

- The amount of knowledge is the total number of credits of the courses (excluding elective courses) that the student registers for the semester.

- The cumulative knowledge amount is the total number of credits of the courses that have been assessed as passing since the beginning of the program
- Grade Point Average (GPA) is the credit-weighted average of the courses the student registers for in that semester (including the courses that are assessed as passing and failing).
- The overall average score of the courses is the credit-weighted average of the courses that the student has enrolled in since the beginning of the program to the time of consideration (including the courses that are assessed as passing and failing).
- The cumulative GPA is the credit-weighted average of the courses rated as passing that the student has accumulated since the beginning of the program to the time of consideration.

VII. RIGHTS AND OBLIGATIONS OF STUDENTS

7.1. Rights of learners

- 1. To fully enjoy the current regimes and policies of the Party and State as well as the regulations of Hanoi National University, Hanoi and the training unit;
- 2. Được phép thôi học vì lý do chủ quan của cá nhân, trong trường hợp này, học viên phải hoàn trả cho đơn vị đào tạo toàn bộ kinh phí đào tạo từ ngân sách nhà nước trong thời gian theo học; Being allowed to drop out for personal reasons, in this case, the student must refund to the training unit all training expenses covered by the state budget during the study period;
- 3. Students are allowed to take a temporary leave and reserve their learning results in the following cases:
- a) Being encouraged to join the armed forces. The period of temporary leave does not count towards the maximum time allowed to study;

- b) Being sick or having an accident requiring long-term treatment is certified by a medical facility. The period of temporary leave does not count towards the maximum time allowed to study;
- c) For personal reasons. In this case, students must study at least one semester at the training unit, not be forced to drop out and must achieve a cumulative GPA of not less than 2.00. Temporary leaves for personal needs count towards the maximum time allowed to study.

Students who take temporari school leave, if they want to continue their studies, must submit a request to the Head of the training unit to resolve it no later than 2 weeks before the expiration of the temporary leave period.

7.1. OBLIGATIONS OF STUDENTS

- 1. Fulfill the obligations of citizens according to the provisions of law. Foreign students must comply with Vietnamese laws and respect Vietnamese customs and practices;
- 2. Strictly comply with the regulations of Vietnam National University, Hanoi and the training unit on student affairs;
- 3. Things students are not allowed to do: use fake diplomas and certificates; violate examination room disciplines, ask for scores; study, take the exam, practice for others or ask others to study, take the exam or practice for them; copy documents without quoting or have essays, theses, graduation projects, scientific research works done by others; carry out or participate in illegal activities. Students who are dishonest and commit frauds in scientific research, essays, theses, and graduation projects will be disciplined from one-year suspension to expulsion.
- 4. Students are responsible for strictly complying with the regulations on discipline in the examination room. Violations will be disciplined at the following levels:
- a) Reprimand: Reminds are applied to students who look at other students' work once, exchanging test papers, having discussions during the exam. Students who are

reprimanded when taking the exam will have 25% of their score deducted from the exams;

- b) Warning: Warnings are made to students who make one of the following violations:
- Has been reprimanded once but during the exam time of that course still continues to violate the regulations;
 - Exchange work, scratch paper with others;
 - Copy other people's work.

Exams with similar conclusions will be treated the same, except where the person being handled has enough evidence to prove that he is really being plagiarized, the head of the training unit may consider a reduction from the warning to reprimand. Students who are warned during the exam will have their score deducted by 50% of the test score for that course;

- c) Exam suspension: This is applied to students who make one of the following violations:
 - Having been warned once, but during the exam time of that course, he continues to violate the regulations;
 - After removing the exam envelop, he is discovered to carry unauthorized items;
 - Send the test questions to outside of the exam room or receive the solutions from outside into the exam room.

Students who are disciplined for taking the test will be given a zero (0) on the exam for that course and must leave the examination room immediately after the decision to suspend the test is issued. The above-mentioned forms of discipline shall be recorded in a written note by the examination officer, evidences will be collected, and the type of disciplination will be clearly stated in the note;

d) Students who take the exam for other students or ask somebody to take the test for them will be disciplined at the level of suspension of 1 year for the first violation and forced expulsion for the second violation.

III. PROGRESS OF TRAINING PROGRAM

- k. Opening: The first week of the first school year
- **1.** Organizing learning and course assessments: Semesters 1, 2, 3 (From the 1st month of the first school year to the end of the 3rd month of the 2nd school year);
- **m.** Organizing the evaluation of the outline, approving the thesis topic: At the end of the 3rd semester (the third month of the second school year);
- **n.** Making a decision to recognize the thesis topic, appoint an instructor: At the beginning of the 4th semester (From the 3rd to the 5th month of the 2nd school year);
- **o.** Students write thesis: Semester 4 (From the 4th to the 6th month of the 2nd academic year);
- **p.** Students report the progress of their thesis to the Departments: At the end of semester 4 (the 6th month of the 2nd school year);
- **q.** Students submit their thesis and relevant documents in the 1st batch: 8th month of the 2nd school year;
- **r.** Make a dossier to request the establishment of a thesis grading committee: 8th month of the 2nd school year;
- s. Organize the thesis defense in the 1st batch: The 9th month of the 2nd school year;
- **t.** Prepare a dossier of request for recognition of the degree and grant of the 1st batch of diplomas for eligible students: 10th month of the 2nd school year.

Notes:

- The organization of learning and assessment of the courses is carried out from the 1st to the 3rd semester of the program.
- The implementation of the student's thesis and the organization of the thesis defense takes place in the 4th semester of the program.

- The official duration of the master's program is 2 years, students can extend the duration and thesis defense but must not exceed 4 years.

IV. SUMMARY OF MODULES

1. ASL6011. LEGAL RESEARCH METHODOLOGY

This course aims to provide graduate students with fundamentals of legal research methodology and equip students with theoretical knowledge about different research methods and how to select and combine scientific research methods to achieve the goal of legal research most effectively. The course also helps students practice essential skills of scientific research, how to conduct a research project, and effectively use research methods in other fields of legal science.

2. ASL6012 LEGAL TEACHING METHODS IN UNIVERSITY

This course provides students with the following knowledge:

- Fundamental legal teaching methodologies.
- Theoretical knowledge of various legal teaching methods;
- How to choose, integrate, and teach law in order to achieve teaching goals in the most effective way.
- Fundamental teaching skills, such as how to organize the legal teaching process and effectively use active teaching methods, particularly knowing how to use assessment forms as an active teaching tool for law students at the university level.

3. CIL6040. REAL RIGHTS

This course aims to provide students with knowledge of concepts, classifications, legal effectiveness, bases for establishment and termination of different real rights, as well as methods for protecting real rights in case of infringement.

4. CIL6041. LAW ON EXTRA-PATRIMONIAL RIGHTS (PERSONAL RIGHTS)

This course aims at providing graduate students with modern, in-depth, up-to-date knowledge of law on personal rights and the skills to apply such knowledge to assess Vietnamese law, to find gaps and propose solutions to improve Vietnamese law on personal rights.

5. CIL6042. COMPARATIVE CONTRACT LAW

This course aims at providing graduate students with modern, in-depth, up-to-date knowledge of comparative contract law in civil law system and common law system, development trends of contemporary contract law, basic content of international conventions or model laws such as the Principles of International Commercial Contracts; thereby helping students in comparing, contrasting and evaluating characteristics of contract law models in the world with Vietnamese contract law, analyzing the relevance

and compatibility between Vietnamese contract law and the development trends of contemporary contract law in order to propose solutions to improve Vietnamese contract law.

6. CIL6043. LAW OF INDUSTRIAL PROPERTY RIGHTS AND PLANTS VARIETY RIGHTS

This course aims at providing graduate students with in-depth knowledge of law on industrial property rights and plants variety rights and the skills to apply such knowledge to solve practical problems, to assess Vietnam's current law on industrial property rights and plants variety rights protection, to find gaps and propose solutions to improve the efficiency of industrial property rights and plants variety rights enforcement.

7. CIL6044. EVIDENCE AND PROOF IN CIVIL PROCEDURE

This course aims at providing graduate students with modern, in-depth knowledge of evidence and proof in civil procedure and the skills to apply such knowledge to solve legal problems in practice, to assess Vietnamese civil procedure law of evidence and proof, to find gaps and propose solutions to improve Vietnamese civil procedure law in this area.

8. CIL6045. GENERAL THEORY ON THE LAW OF OBLIGATIONS

The course provides students with a system of in-depth knowledge related to the general theory of the Law of Obligations such as concepts, classifications, legal features, basement for termination of obligations.

9. CIL6046. THEORY OF CIVIL LAW SOURCES

The course "Theory of civil law sources" aims to provide students with a deeper understanding of different civil law sources, their characteristics, nature, classification, role, and application, enable students to apply such knowledge to solve problems related to civil law issues, mainly theoretical and practical issues focused on legal acts; legal documents; customs; the analogy of law; basic principles; case law; justice

10. CIL.6047. LAW OF COPYRIGHT

This course aims at providing graduate students with in-depth knowledge of law on copyright and the skills to apply such knowledge to solve practical problems concerning copyright law, to assess Vietnam's current copyright law, to find gaps and propose solutions to improve the efficiency and effectiveness of copyright enforcement in Vietnam.

11. CIL6048. LAW OF NON-CONTRACTUAL DAMAGES LIABILITY (TORT LAW)

The course aims to provide students with an in-depth knowledge of the general theory of the law of non-contractual damages liability (Tort Law) such as structure, function, legal characteristics, subject, and basic principles, and enable students to apply theory and law on compensation for non-contractual damages liability to solve practical problems.

12. CIL6049. MATRIMONIAL PROPERTY REGIME

The course "Matrimonial property regime" aims at providing graduate students with indepth knowledge of matrimonial property regime and the skills to apply such knowledge to solve the practical disputes in Vietnam, to find out gaps and propose solutions to improve Vietnamese matrimonial property regime law.

13. CIL6050. LAW OF CIVIL JUDGMENT ENFORCEMENT

This course aims at providing graduate students with modern, in-depth knowledge of law on civil judgment enforcement and the skills to apply such knowledge to solve legal problems in practice, to assess Vietnamese law of civil judgment enforcement, to find gaps and propose solutions to improve Vietnamese law of civil judgment.

14. CIL6051. DIVORCE AND ITS LEGAL CONSEQUENCES

The course "Divorce and its legal consequences" aims at providing graduate students with in-depth knowledge of divorce and the skills to apply such knowledge in order to solve the practical disputes in Vietnam, to find out gaps and propose solutions to improve Vietnamese law on divorce and its legal consequences.

15. CIL6052. APPLICATION OF THE CIVIL CODE TO BUSINESS, COMMERCIAL AND LABOR DISPUTE RESOLUTION

The course aims to help learners understand the application of the Civil Code appropriately and enhance their problem-solving skills to resolve business, commercial, and labor disputes. The course clarifies the relationship between the Civil Code and other sources of commercial and labor law. It builds skills related to case analysis, normative analysis, and problem-solving if there are no specific regulations on business, commercial, and labor relations.

16. CIL6053. INHERITANCE LAW

The course provides students with in-depth knowledge of inheritance law from a theoretical perspective to current Vietnamese law. Specifically, the course provides the following knowledge: Some basic concepts and legal issues in the general part such as the leaver, heir, inheritance, inheritance management, the statute of limitations for initiating an inheritance lawsuit; Legal issues of wills and wills validity; Inheritance issues according to the law such as inheritance and inheritance.

17. CIL6054. LEGAL PERSONS

The module equips learners with information and knowledge about the theory of legal persons, the classification of legal persons, and the organization and operation of legal persons and aims to build skills in settling disputes relating to legal persons. The module also provides in-depth knowledge of legal rules for each specific type of legal person.

18. CIL6055. INTERLECTUAL PROPERTY DISPUTE RESOLUTION

This course aims at providing graduate students with in-depth knowledge of intellectual property (IP) dispute resolution and the skills to apply such knowledge to solve IP disputes in practice, to assess Vietnam's current situation of IP dispute resolution, to find gaps and propose solutions to improve the efficiency and effectiveness of IP dispute resolution in Vietnam

19. CIL6056. THE LAW OF AGENCY

The course provides students with in-depth knowledge of representative law from a theoretical perspective, current Vietnamese law, to comparative law. Specifically, the module offers the following expertise: Concept, function, structure of representation; Some of the legal issues related to the agent are not authorized representation and agent abuse of authority.

20. CIL6057. LAW OF TRANSPORTATION CONTRACTS

The course equips learners systematically and intensively with knowledge and skills related to the law of transportation contracts, specifically contracts for transport of passengers, contracts for the transport of property with either shipping fees or free shipping and either standard shipping or irregular shipping by different means of transportation.

21. CIL6058. LAW OF LEASING

This course aims at providing graduate students with modern, in-depth knowledge of comparative civil procedure law and the skills to apply such knowledge to assess Vietnamese civil procedure law, to find gaps and propose solutions to improve Vietnamese civil procedure law in line with global trends.

22. CIL.6059. LAW ON ASSOCIATION CONTRACTS

This course aims at providing graduate students with modern, in-depth knowledge of law on association contracts and the skills to apply such knowledge to assess Vietnamese law, to find gaps and propose solutions to improve Vietnamese law on association contracts.

23. CIL6060. COMPARATIVE CIVIL PROCEDURE

This course aims at providing graduate students with modern, in-depth knowledge of comparative civil procedure law and the skills to apply such knowledge to assess Vietnamese civil procedure law, to find gaps and propose solutions to improve Vietnamese civil procedure law in line with global trends.

24. CIL6061. COMPARATIVE MARRIAGE AND FAMILY LAW

The course "Comparative Marriage and Family Law" aims at providing graduate students with modern, in-depth knowledge of comparative marriage and family law and the skills to apply such knowledge to assess Vietnamese marriage and family law, to find

gaps and propose solutions to improve Vietnamese marriage and family law in line with global trends.

25. CIL6062. LAW ON COLLECTIVE CONTRACT

This course aims at providing graduate students with modern, in-depth knowledge of law on collective contracts and the skills to apply such knowledge to assess Vietnamese law, to find gaps and propose solutions to improve Vietnamese law on collective contracts.

26. CIL6063. ADVANCED ROMAN LAW

This course aims at providing graduate students with modern, in-depth up-to-date knowledge of Roman private law and to compare with and to find gaps and propose solutions to improve Vietnamese civil law.

6.2. Assessment of the learning results

Students' learning results are assessed after each semester according to the following criteria:

- The amount of knowledge is the total number of credits of the courses (excluding elective courses) that the student registers for the semester.
- The cumulative knowledge amount is the total number of credits of the courses that have been assessed as passing since the beginning of the program
- Grade Point Average (GPA) is the credit-weighted average of the courses the student registers for in that semester (including the courses that are assessed as passing and failing).
- The overall average score of the courses is the credit-weighted average of the courses that the student has enrolled in since the beginning of the program to the time of consideration (including the courses that are assessed as passing and failing).
- The cumulative GPA is the credit-weighted average of the courses rated as passing that the student has accumulated since the beginning of the program to the time of consideration.

VII. RIGHTS AND OBLIGATIONS OF STUDENTS

7.1. Rights of learners

- 1. To fully enjoy the current regimes and policies of the Party and State as well as the regulations of Hanoi National University, Hanoi and the training unit;
- 2. Being allowed to drop out for personal reasons, in this case, the student must refund to the training unit all training expenses covered by the state budget during the study period;
- 3. Students are allowed to take a temporary leave and reserve their learning results in the following cases:
- a) Being encouraged to join the armed forces. The period of temporary leave does not count towards the maximum time allowed to study;
- b) Being sick or having an accident requiring long-term treatment is certified by a medical facility. The period of temporary leave does not count towards the maximum time allowed to study;
- c) For personal reasons. In this case, students must study at least one semester at the training unit, not be forced to drop out and must achieve a cumulative GPA of not less than 2.00. Temporary leaves for personal needs count towards the maximum time allowed to study.

Students who take temporary school leave, if they want to continue their studies, must submit a request to the Head of the training unit to resolve it no later than 2 weeks before the expiration of the temporary leave period.

7.2. Obligations of students

- 1. Fulfill the obligations of citizens according to the provisions of law. Foreign students must comply with Vietnamese laws and respect Vietnamese customs and practices;
- 2. Strictly comply with the regulations of Vietnam National University, Hanoi and the training unit on student affairs;
- 3. Things students are not allowed to do: use fake diplomas and certificates; violate examination room disciplines, ask for scores; study, take the exam, practice for others or ask others to study, take the exam or practice for them; copy documents without quoting or have essays, theses, graduation projects, scientific research works done by others; carry out or participate in illegal activities. Students who are dishonest and commit frauds in scientific research, essays, theses, and graduation projects will be disciplined from one-year suspension to expulsion.
- 4. Students are responsible for strictly complying with the regulations on discipline in the examination room. Violations will be disciplined at the following levels:
- a) Reprimand: Reminds are applied to students who look at other students' work once, exchanging test papers, having discussions during the exam. Students who are reprimanded when taking the exam will have 25% of their score deducted from the exams;
- b) Warning: Warnings are made to students who make one of the following violations:
- Has been reprimanded once but during the exam time of that course still continues to violate the regulations;
 - Exchange work, scratch paper with others;
 - Copy other people's work.

Exams with similar conclusions will be treated the same, except where the person being handled has enough evidence to prove that he is really being plagiarized, the head of the training unit may consider a reduction from the warning to reprimand. Students who are warned during the exam will have their score deducted by 50% of the test score for that course;

- c) Exam suspension: This is applied to students who make one of the following violations:
 - Having been warned once, but during the exam time of that course, he/she continues to violate the regulations;
 - After removing the exam envelop, he/she is discovered to carry unauthorized items;
 - Send the test questions to outside of the exam room or receive the solutions from outside into the exam room.

Students who are disciplined for taking the test will be given a zero (0) on the exam for that course and must leave the examination room immediately after the decision to suspend the test is issued. The above-mentioned forms of discipline shall be recorded in a written note by the examination officer, evidences will be collected, and the type of disciplination will be clearly stated in the note;

d) Students who take the exam for other students or ask somebody to take the test for them will be disciplined at the level of suspension of 1 year for the first violation and forced expulsion for the second violation.

3.2. Training sequences:

u. Opening: The first week of the first school year

- **v.** Organizing learning and course assessments: Semesters 1, 2, 3 (From the 1st month of the first school year to the end of the 3rd month of the 2nd school year);
- **w.** Organizing the evaluation of the outline, approving the thesis topic: At the end of the 3rd semester (the third month of the second school year);
- **x.** Making a decision to recognize the thesis topic, appoint an instructor: At the beginning of the 4th semester (From the 3rd to the 5th month of the 2nd school year);

- **y.** Students write thesis: Semester 4 (From the 4th to the 6th month of the 2nd academic year);
- **z.** Students report the progress of their thesis to the Departments: At the end of semester 4 (the 6th month of the 2nd school year);
- **aa.** Students submit their thesis and relevant documents in the 1st batch: 8th month of the 2nd school year;
- **bb.**Make a dossier to request the establishment of a thesis grading committee: 8th month of the 2nd school year;
- cc. Organize the thesis defense in the 1st batch: The 9th month of the 2nd school year;
- **dd.**Prepare a dossier of request for recognition of the degree and grant of the 1st batch of diplomas for eligible students: 10th month of the 2nd school year.

3.3. Notes:

- The organization of learning and assessment of the courses is carried out from the 1st to the 3rd semester of the program.
- The implementation of the student's thesis and the organization of the thesis defense takes place in the 4th semester of the program.
- The official duration of the master's program is 2 years, students can extend the duration and thesis defense but must not exceed 4 years.

- 1. PHI5001. Philosophy: According to general rule.
- 2. ENG5001 (RUS5001; FRE5001; GER5001; CHI5001). Basic foreign language: According to general rule.

3. SOL6001. Legal Research methodology: 2 credits

This course aims to provide graduate students with fundamentals of legal research methodology and equip students with theoretical knowledge about different research methods and how to select and combine scientific research methods to achieve the goal of legal research most effectively. The course also helps students practice essential skills of scientific research, how to conduct a research project, and effectively use research methods in other fields of legal science.

4. CIL6040. Real Rights: 2 credits

This course aims to provide students with knowledge of concepts, classifications, legal effectiveness, bases for establishment and termination of different real rights, as well as methods for protecting real rights in case of infringement.

5. CIL6041. Law on extra-patrimonial rights (Personal Rights)

This course aims at providing graduate students with modern, in-depth, up-to-date knowledge of law on personal rights and the skills to apply such knowledge to assess Vietnamese law, to find gaps and propose solutions to improve Vietnamese law on personal rights.

6. CIL6042. Comparative Contract Law: 2 credits

This course aims at providing graduate students with modern, in-depth, up-to-date knowledge of comparative contract law in civil law system and common law system, development trends of contemporary contract law, basic content of international conventions or model laws such as the Principles of International Commercial Contracts; thereby helping students in comparing, contrasting and evaluating characteristics of contract law models in the world with Vietnamese contract law, analyzing the relevance and compatibility between Vietnamese contract law and the development trends of contemporary contract law in order to propose solutions to improve Vietnamese contract law.

7. CIL6043. Laws of Industrial Property Rights and Plants Variety Rights: 2 credits

This course aims at providing graduate students with in-depth knowledge of law on industrial property rights and plants variety rights and the skills to apply such knowledge to solve practical problems, to assess Vietnam's current law on industrial property rights and plants variety rights protection, to find gaps and propose solutions to improve the efficiency of industrial property rights and plants variety rights enforcement.

8. CIL6044. Evidence and proof in civil procedure: 2 credits

This course aims at providing graduate students with modern, in-depth knowledge of evidence and proof in civil procedure and the skills to apply such knowledge to solve legal problems in practice, to assess Vietnamese civil procedure law of evidence and proof, to find gaps and propose solutions to improve Vietnamese civil procedure law in this area.

9. CIL6045. General theory on the law of obligations: 3 credits

The course provides students with a system of in-depth knowledge related to the general theory of the Law of Obligations such as concepts, classifications, legal features, basement for termination of obligations.

10. CIL6046. Theory of civil law sources: 3 credits

The course "Theory of civil law sources" aims to provide students with a deeper understanding of different civil law sources, their characteristics, nature, classification, role, and application, enable students to apply such knowledge to solve problems related to civil law issues, mainly theoretical and practical issues focused on legal acts; legal documents; customs; the analogy of law; basic principles; case law; justice

11. CIL.6047. Law of copyright

This course aims at providing graduate students with in-depth knowledge of law on copyright and the skills to apply such knowledge to solve practical problems concerning copyright law, to assess Vietnam's current copyright law, to find gaps and propose solutions to improve the efficiency and effectiveness of copyright enforcement in Vietnam.

12. CIL6048. Law of non-contractual damages liability (Tort Law)

The course aims to provide students with an in-depth knowledge of the general theory of the law of non-contractual damages liability (Tort Law) such as structure, function, legal characteristics, subject, and basic principles, and enable students to apply theory and law on compensation for non-contractual damages liability to solve practical problems.

13. CIL6049. Matrimonial Property Regime

The course "Matrimonial property regime" aims at providing graduate students with indepth knowledge of matrimonial property regime and the skills to apply such knowledge to solve the practical disputes in Vietnam, to find out gaps and propose solutions to improve Vietnamese matrimonial property regime law.

14. CIL6050. Law of civil judgement enforcement

This course aims at providing graduate students with modern, in-depth knowledge of law on civil judgment enforcement and the skills to apply such knowledge to solve legal problems in practice, to assess Vietnamese law of civil judgment enforcement, to find gaps and propose solutions to improve Vietnamese law of civil judgment.

15. CIL6051. Divorce and its legal consequences

The course "Divorce and its legal consequences" aims at providing graduate students with in-depth knowledge of divorce and the skills to apply such knowledge in order to solve the practical disputes in Vietnam, to find out gaps and propose solutions to improve Vietnamese law on divorce and its legal consequences.

16. CIL6052. Application of the civil code to business, commercial and labor dispute resolution

The course aims to help learners understand the application of the Civil Code appropriately and enhance their problem-solving skills to resolve business, commercial, and labor disputes. The course clarifies the relationship between the Civil Code and other sources of commercial and labor law. It builds skills related to case analysis, normative analysis, and problem-solving if there are no specific regulations on business, commercial, and labor relations.

17. CIL6053. Inhertance Law

The course provides students with in-depth knowledge of inheritance law from a theoretical perspective to current Vietnamese law. Specifically, the course provides the following knowledge: Some basic concepts and legal issues in the general part such as the

leaver, heir, inheritance, inheritance management, the statute of limitations for initiating an inheritance lawsuit; Legal issues of wills and wills validity; Inheritance issues according to the law such as inheritance and inheritance.

18. CIL6054. Legal Persons

The module equips learners with information and knowledge about the theory of legal persons, the classification of legal persons, and the organization and operation of legal persons and aims to build skills in settling disputes relating to legal persons. The module also provides in-depth knowledge of legal rules for each specific type of legal person.

19. CIL6055. Interlectual property dispute resolution

This course aims at providing graduate students with in-depth knowledge of intellectual property (IP) dispute resolution and the skills to apply such knowledge to solve IP disputes in practice, to assess Vietnam's current situation of IP dispute resolution, to find gaps and propose solutions to improve the efficiency and effectiveness of IP dispute resolution in Vietnam

20. CIL6056. The Law of Agency

The course provides students with in-depth knowledge of representative law from a theoretical perspective, current Vietnamese law, to comparative law. Specifically, the module offers the following expertise: Concept, function, structure of representation; Some of the legal issues related to the agent are not authorized representation and agent abuse of authority.

21. CIL6057. Law of Transportation Contracts

The course equips learners systematically and intensively with knowledge and skills related to the law of transportation contracts, specifically contracts for transport of passengers, contracts for the transport of property with either shipping fees or free shipping and either standard shipping or irregular shipping by different means of transportation.

22. CIL6058. Law of Leasing

This course aims at providing graduate students with modern, in-depth knowledge of comparative civil procedure law and the skills to apply such knowledge to assess Vietnamese civil procedure law, to find gaps and propose solutions to improve Vietnamese civil procedure law in line with global trends.

23. CIL.6059. Law on Association Contracts

This course aims at providing graduate students with modern, in-depth knowledge of law on association contracts and the skills to apply such knowledge to assess Vietnamese law, to find gaps and propose solutions to improve Vietnamese law on association contracts.

24. CIL6060. Comparative Civil Procedure

This course aims at providing graduate students with modern, in-depth knowledge of comparative civil procedure law and the skills to apply such knowledge to assess Vietnamese civil procedure law, to find gaps and propose solutions to improve Vietnamese civil procedure law in line with global trends.

25. CIL6061. Comparative Mariage and Family Law

The course "Comparative Marriage and Family Law" aims at providing graduate students with modern, in-depth knowledge of comparative marriage and family law and the skills to apply such knowledge to assess Vietnamese marriage and family law, to find gaps and propose solutions to improve Vietnamese marriage and family law in line with global trends.

26. CIL6062. Law on Collective Contracy

This course aims at providing graduate students with modern, in-depth knowledge of law on collective contracts and the skills to apply such knowledge to assess Vietnamese law, to find gaps and propose solutions to improve Vietnamese law on collective contracts.

27. CIL6063. Advanced Roman Law

This course aims at providing graduate students with modern, in-depth up-to-date knowledge of Roman private law and to compare with and to find gaps and propose solutions to improve Vietnamese civil law.

28. CIL6064. Law on secured transactions

This course provides graduate students with in-depth theoretical knowledge of law on secured transactions such as the concept, characteristics, and classification of secured transactions, the overriding goal of secured transactions law, different models of secured transactions law, characteristics of modern secured transactions law, and fundamental aspects of secured transactions law (creation, perfection, priority and enforcement of a security right). From a theoretical and comparative lens, students can assess current Vietnamese law on secured transactions, apply theoretical knowledge to solve practical problems concerning secured transactions law, and propose solutions to improve Vietnamese law on secured transactions to meet the demand of international integration.

6.2. Assessment of the learning results

Students' learning results are assessed after each semester according to the following criteria:

- The amount of knowledge is the total number of credits of the courses (excluding elective courses) that the student registers for the semester.
- The cumulative knowledge amount is the total number of credits of the courses that have been assessed as passing since the beginning of the program
- Grade Point Average (GPA) is the credit-weighted average of the courses the student registers for in that semester (including the courses that are assessed as passing and failing).
- The overall average score of the courses is the credit-weighted average of the courses that the student has enrolled in since the beginning of the program to the time of consideration (including the courses that are assessed as passing and failing).
- The cumulative GPA is the credit-weighted average of the courses rated as passing that the student has accumulated since the beginning of the program to the time of consideration.

VII. RIGHTS AND OBLIGATIONS OF STUDENTS

7.1. Rights of learners

1. To fully enjoy the current regimes and policies of the Party and State as well as the regulations of Hanoi National University, Hanoi and the training unit;

- 2. Being allowed to drop out for personal reasons, in this case, the student must refund to the training unit all training expenses covered by the state budget during the study period;
- 3. Students are allowed to take a temporary leave and reserve their learning results in the following cases:
- a) Being encouraged to join the armed forces. The period of temporary leave does not count towards the maximum time allowed to study;
- b) Being sick or having an accident requiring long-term treatment is certified by a medical facility. The period of temporary leave does not count towards the maximum time allowed to study;
- c) For personal reasons. In this case, students must study at least one semester at the training unit, not be forced to drop out and must achieve a cumulative GPA of not less than 2.00. Temporary leaves for personal needs count towards the maximum time allowed to study.

Students who take temporari school leave, if they want to continue their studies, must submit a request to the Head of the training unit to resolve it no later than 2 weeks before the expiration of the temporary leave period.

7.1. OBLIGATIONS OF STUDENTS

- 1. Fulfill the obligations of citizens according to the provisions of law. Foreign students must comply with Vietnamese laws and respect Vietnamese customs and practices;
- 2. Strictly comply with the regulations of Vietnam National University, Hanoi and the training unit on student affairs;
- 3. Things students are not allowed to do: use fake diplomas and certificates; violate examination room disciplines, ask for scores; study, take the exam, practice for others or ask others to study, take the exam or practice for them; copy documents without quoting or have essays, theses, graduation projects, scientific research works done by others; carry out or participate in illegal activities. Students who are dishonest and commit frauds in scientific research, essays, theses, and graduation projects will be disciplined from one-year suspension to expulsion.
- 4. Students are responsible for strictly complying with the regulations on discipline in the examination room. Violations will be disciplined at the following levels:
- a) Reprimand: Reminds are applied to students who look at other students' work once, exchanging test papers, having discussions during the exam. Students who are reprimanded when taking the exam will have 25% of their score deducted from the exams:
- b) Warning: Warnings are made to students who make one of the following violations:
- Has been reprimanded once but during the exam time of that course still continues to violate the regulations;
 - Exchange work, scratch paper with others;
 - Copy other people's work.

Exams with similar conclusions will be treated the same, except where the person being handled has enough evidence to prove that he is really being plagiarized, the head of the training unit may consider a reduction from the warning to reprimand. Students who are warned during the exam will have their score deducted by 50% of the test score for that course;

- c) Exam suspension: This is applied to students who make one of the following violations:
 - Having been warned once, but during the exam time of that course, he/she continues to violate the regulations;
 - After removing the exam envelop, he/she is discovered to carry unauthorized items;
 - He/she send the test questions to outside of the exam room or receive the solutions from outside into the exam room.

Students who are disciplined for taking the test will be given a zero (0) on the exam for that course and must leave the examination room immediately after the decision to suspend the test is issued. The above-mentioned forms of discipline shall be recorded in a written note by the examination officer, evidences will be collected, and the type of disciplination will be clearly stated in the note;

d) Students who take the exam for other students or ask somebody to take the test for them will be disciplined at the level of suspension of 1 year for the first violation and forced expulsion for the second violation.
